TOWN OF LA POINTE RENTAL POLICY *All rentals are first come, first served*

Rec Center Building and Shelter:

Anyone renting the Recreation Center Building must contact the Town Foreman at (715) 747-6855 to make arrangements for getting the Rec Center key and returning the Rec Center key. Please contact the Town Foreman at least one week prior to the event.

The Rec Center Building and Shelter is **not available** during the summer months (second week in June until the last week in August) for the Rec Center Program which runs Monday—Friday 8:30am—3:30pm. The Rec Center Building and Shelter are available for rental after 3:30 pm Monday—Friday as well as all day Saturday and Sunday.

The Rec Center Building and Shelter are **not available** for rental for the following annual events:

Graduation (generally held the first or second Sunday of June); In Line Skate Event the third Saturday in June;

JFD Bikers - the weekend after Father's Day; Emergency Services Fundraiser - Fourth of July;

Star Bar Softball Tournament - second Saturday and Sunday in August; Fall Fest - third Saturday in October.

The Recreation Center building has inside and outside bathrooms, a central room for about 50 people, a small kitchen area with a non-commercial refrigerator and microwave oven. There is no stove and no sink in the kitchen area. The Shelter area has charcoal/wood grills available.

A reservation of the Rec Center Shelter or Building does not guarantee exclusive use of the baseball field, tennis courts or playground area. Please be aware the ball field is used extensively for Men's and Women's baseball and softball games as well as Little League and Soccer games.

Please call the Town Hall at 715-747-6913 to request an application to reserve the Rec Center Shelter and/or Grounds. The application is also available on the Town website: townoflapointe.com.

Joni's Beach Shelter

Please note that this is a public beach so rental reservations do not guarantee exclusive use of the area or the beach.

Rental reservations are not allowed after 10:00pm. No overnight camping is allowed at Joni's Beach.

Please call the Town Hall at 715-747-6913 to request an application to reserve the Joni's Beach shelter.

The application is available on the Town website: townoflapointe.com. Small charcoal/wood picnic grills available.

Shelter at Big Bay Town Park*:

4 hour time limit*. Please note that this is a campground so rental of the shelter does not guarantee exclusive use of the campground area around the shelter. Rental reservations are not allowed after 10:00pm.

Please call the Town Hall at 715-747-6913 to request an application to reserve the Shelter at Big Bay Town Park.

The application is also available on the Town website: townoflapointe.com. 2 large and 2 small charcoal/wood grills.

***Availability is restricted to one (1) 4 hour reservation/day to ensure access and use by campers and the public.**

If you are a camper and wish to reserve the shelter at Big Bay Town Park no fees will be charged but you will need to fill out an application in order to reserve the shelter. Applications are available at the Town Park Building or on the Town website: townoflapointe.com. Reservations can also be made by calling the Town Hall at 715-747-6913 or emailing: townhall@cheqnet.net or info@townoflapointewi.gov. Though no deposit fees are charged, kindly keep in mind the following:

All Rentals:

The Town of La Pointe Roads or Parks Departments will inspect each site after a scheduled reservations.

Groundskeepers will look for the following items to be completed. Please ensure these are completed before the end of your event or your security deposit will be deducted \$26.37 (*includes sales tax*) for each item not completed.

- ___ Garbage placed in appropriate containers.
- ___ Tables cleared of debris and put back in their original location
- ___ Decorations removed
- ___ Litter picked up.
- ___ Key for the Rec Center Building returned to Town Foreman

Destruction of property will not be tolerated.

Excess Clean Up Costs will be assessed per Chapter 347:Section 347-10(K)

Any person or group using Town of La Pointe property that engages in either excessive or abusive alcohol consumption or any type of disorderly or destructive behavior will not be allowed to use the property in the future.
