

Chapter 227

CONSERVANCY AREA

[HISTORY: Adopted by the Town Board of the Town of La Pointe 10-8-1991 by Ord. No. 108-91. Amendments noted where applicable.]

§ 227-1. Amundsen Road Conservancy Area.

The following described parcel of land consisting of a strip of land three rods wide on the north side of Lot Three, Section 27, Township 51 North, Range Two West, Town of La Pointe, Ashland County, Wisconsin, is designated the Amundsen Road Conservancy Area: all that portion of such strip of land 49.5 feet wide lying east of a line 1,295 feet east of the center line of School House Road, terminating on the east at the normal or ordinary high-water mark of Lake Superior. This area is located within the parcel deeded to the Town of La Pointe in the deed recorded May 6, 1930, in Volume 121 on page 576 as Document X850098 in the office of the Register of Deeds of Ashland County, Wisconsin.

§ 227-2. Purpose.

The Amundsen Road Conservancy Area shall be left and maintained in its natural condition for the purpose of aesthetic enjoyment.

§ 227-3. Use.

The Amundsen Road Conservancy Area shall be open to use by the public subject to the following restrictions:

- A. No motor vehicle or other vehicle of any type shall be allowed. Public access shall be by pedestrians only.
- B. There shall be no improvements made unless agreed to in writing by and between those parties who are parties to the agreement recorded on April 26, 1991, in Volume 431 of Records on page 451 as Document X231300 in the office of the Register of Deeds for Ashland County, Wisconsin.
- C. No camping or pitching of tents is permitted.
- D. No fires or smoking shall be permitted.
- E. Alcoholic beverages shall not be possessed or consumed on such premises.
- F. No excavating or digging is permitted on said premises.
- G. No cutting of timber, brush or vegetation is allowed.
- H. There shall be no development of any sort and no erection of structures or

buildings.

- I. There shall be no group picnicking. A group for the purpose of this restriction is more than five persons.

§ 227-4. Promotion or advertisement.

The Town will not publish, promote or advertise the location or availability of the Amundsen Road Conservancy Area, except the Town will publish this chapter as required by law.

§ 227-5. Violations and penalties.

Any person violating a provision of this chapter may be required to forfeit not less than \$10 nor more than \$500, together with the costs incurred by the Town of La Pointe in prosecuting such violation, together with such amount, if any, the court determines shall be paid to the Town of La Pointe for restitution of any damage caused. Law enforcement officers are authorized to issue citations for violations of this chapter, with such citations to comply with the requirements of § 66.0113, Wis. Stats., or any subsequent section of Wisconsin Statutes dealing with the subject of citations for ordinance violations.
