AMENDMENT TO: RESOLUTION # 2018-0612A

(Amended, item #8 added)

WHEREAS, §82.03(7) Wisconsin Statutes entitled "HIGHWAY NAMES" provides that the town board shall by ordinance assign a name to each of the roads that are under the town's jurisdiction.

NOW, THEREFORE, the Town Board of the Town of La Pointe in Ashland County does ordain as follows:

The following roads in the Town of La Pointe that are under the Town's jurisdiction and which are open are assigned the following names:

- 1. Abby Ln A private road serving as ingress and egress for the Hartzell subdivision running north and then west from Mondamin Trl up and to a point of blocked access. Identified as parcel #014-00192-0507. Identified as a thoroughfare though is a dead-end road.
- 2. Bad River Rd A private dead-end road formerly known as Kron-Dahlin Reservation extends from Kron Dahlin Ln to the south.
- 3. Bayhill Cottage Rd W A private dead-end road running west off Mondamin Trl.
- 4. Bayhill Cottage Rd E –A private road running east then north and south off Mondamin Trl terminating at dead-ends. Formerly known as Bayhill Cottage Circle and Bayhill Cottage Court.
- 5. Big Oak Blvd A private dead-end road running south off South Shore Rd.
- 6. **Bojo Ln E** A private single lane road running east from Old Fort Rd to dead-end, the south fork is considered a driveway.
- 7. Bojo Ln W A private single lane road running west from Old Fort Rd to a dead-end.
- 8. Brians Rd A private dead-end road AKA Ruff Road, White Pine Road, located at the north end of Big Arns Rd running east to a dead end.
- 9. Deer Woods Ln A private dead-end road running north from Middle Rd. Serving Deer Wood Subdivision.
- 10. Evies Ln A private dead-end road running west from Mondamin Trl.
- 11. Fisherman Ln A private dead-end road running north then northeast from Big Bay Rd.
- 12. Hermit Ln A private dead-end road formerly known as Cramer Lane serving North Shore Heights running to the northwest of South Shore Road to a dead-end, this name change is at the request of property owners, (North Shore Heights Association)
- 13. Haines Rd A private road running north from Hagen Rd at the State Park entrance to camping and picnic areas.
- 14. Harley Rd A private dead-end road located approximately 500' east of the S curve on the south side of Big Bay Rd.
- **15. Islewood Rd** A private dead-end road located off the south side of South Shore Rd meandering to the southwest.

- 16. Lucy in the Sky Dr A private dead-end road running south and to the west off Mondamin Trl, directly across from Penny Ln.
- 17. Minnewawa Dr A private dead-end road running west off Mondamin Trl the golf course.
- 18. Red Oak Ln— A private dead-end road running north off South Shore Rd.
- 19. Sarah Mary Ln A private dead-end road running to the northwest off Mondamin Trl.
- **20. Shop Rd** A private road running south from Middle Rd serving Hartzell property and Nelson Construction.
- 21. Spirit Ln A private dead-end road running east off Benjamin Blvd.
- 22. Stockton Rd A private dead-end road serving a portion of North Shore Heights running west off North Shore Rd.
- 23. Stone Point Ln A private dead-end road running south off Hagen Rd.
- **24. Sunny Slope Pvt** The continuation of Sunny Slope town road serving multiple properties to the east and north.
- 25. Umbrage Rd A private dead-end road running north off Big Bay Rd.
- **26.** Wilderness Rd A private road running east from Haines Rd in Big Bay State Park to the parking lot.
- 27. Woods Edge Trl A private dead-end road running northwest off Evies Ln.
