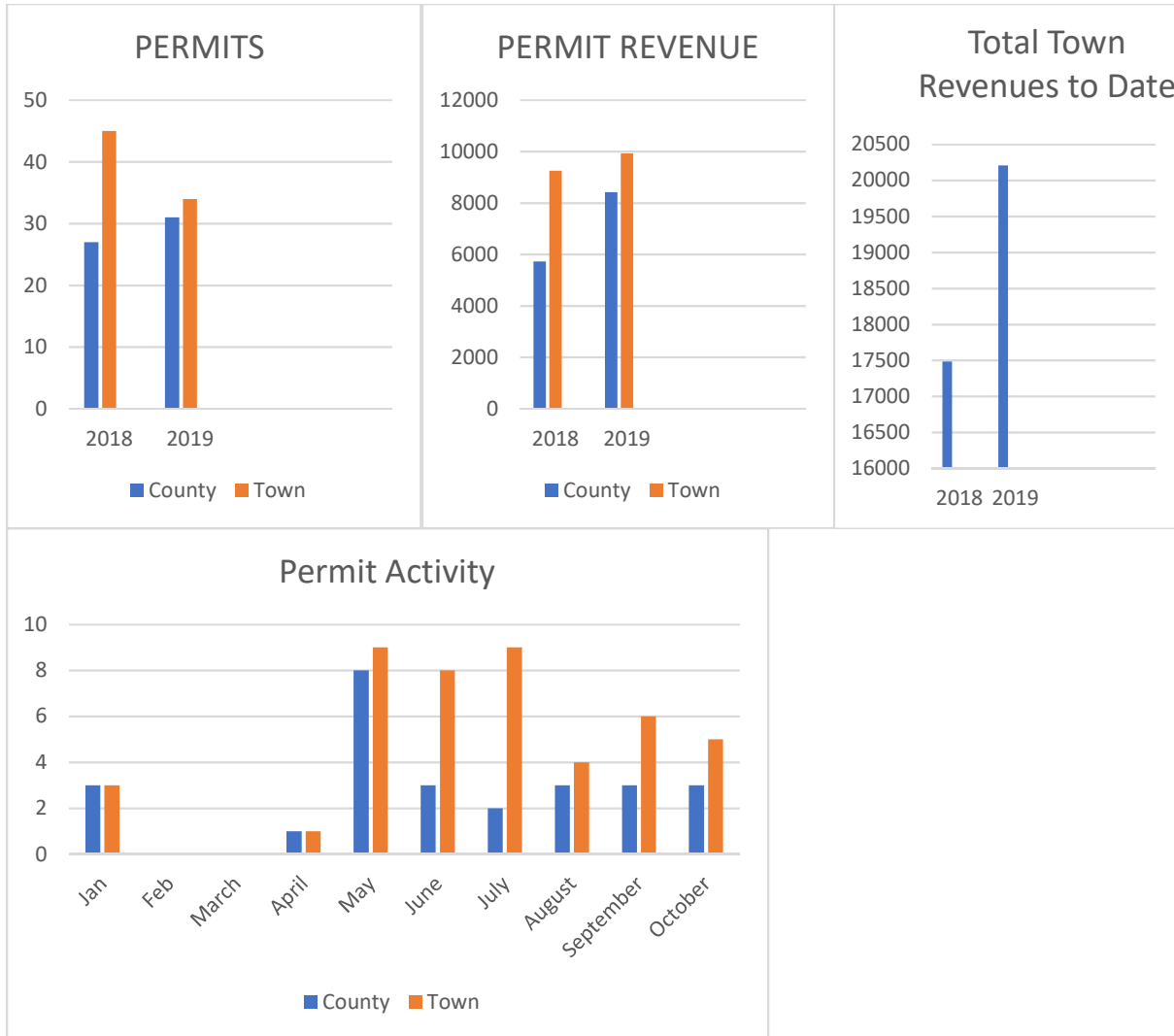
- Total Permit Revenue is up 25% from this date last year.
