Possible longer terms for loans from 5 years to 10 or 20 years. Barb Nelson is going to take a better look at the 2019 figures to see how the end of the year is looking. Discussion on options for raising the tax levy over the allowable limit. Barb to run the figures for a 15% increase. Discussion on taking out the Rec Center bathroom remodel out of the budget for 2020 \$105,000), and having the Fire Department use designated funds for Capital Outlay instead of the general fund.
