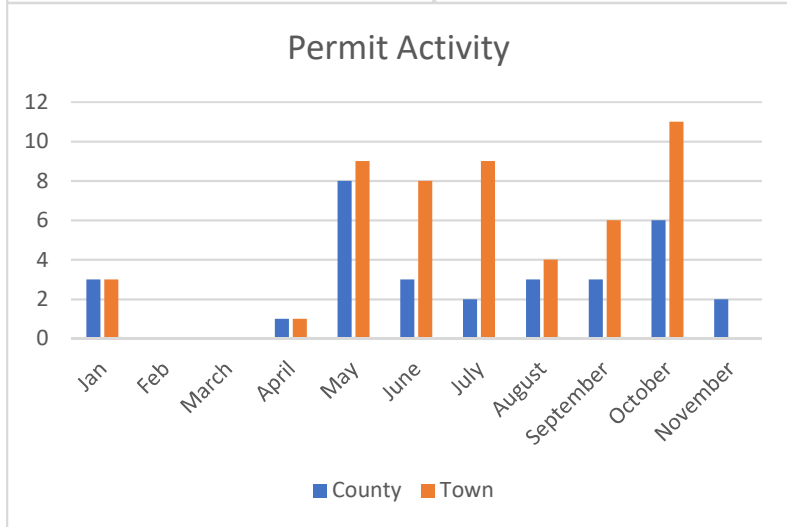
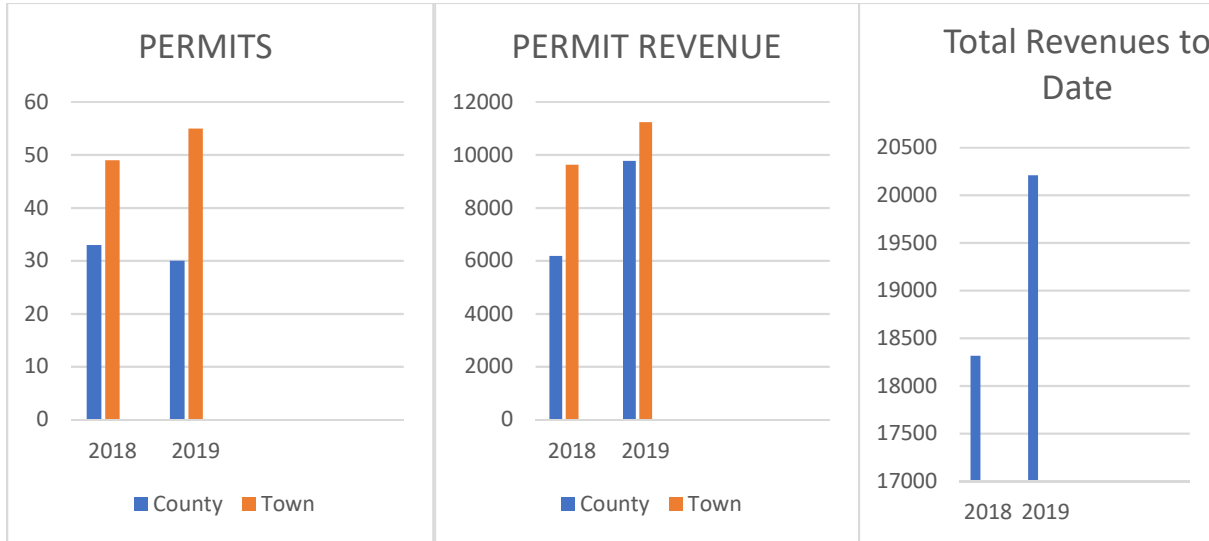
- Total Permit Revenue is up 24% from this date last year.

- Overall Revenue is up 20 % from this date last year.

- 2 County and Town Permits are pending, both awaiting Sanitary Permits prior to issuance.
- Fire Numbers have been queried by Road, Zone, Section and Township. This information is in review with the County Emergency Services. The County staff believe the grid system should be enhanced to accommodate projected growth and correct existing problems. I have asked if they would be willing to meet with the Town Board and the Town Plan Commission to address alternatives and solutions.
