V. New Business

a. Review of Draft Ordinance – Mobile Vendors

Review of draft language dated 10-8-19. It is the consensus of the Town Plan Commission that this language is in keeping with the needs of the Town and recommends approval of this draft language. The TPC also recommends that the vendor(s), apply for and receive a permit from the town for the duration of the activity.

d. Commissioner Follis, Update on Workshop

A brief discussion of content by Follis and Peters. Much of the content was related to ACT 67, and Peters was happy to report folks in attendance were appreciative of our Zoning Ordinance. stated that the group saw our zoning ordinance as current and up to date.

e. Town Plan Commission Budget review

ZA reports the Town is facing fiscal constraints leading to each department needing to re-assess their budget and propose feasible cuts. The ZA has proposed cutting 24 budgeted TPC meeting to 15 for 2020 and has trimmed monies allocated for legal services. While there were undesignated funds allocated for the Public Arts Committee, this proposal has been cut. Funds allocated or denied to the Public Arts Committee do not affect the function of the TPC or Zoning.

There was discussion of increasing the CUP and Special Exception Fees however the consensus is to keep those fees as is.

Rental fees were discussed and while this is a Town Ordinance and not a Zoning Ordinance an increase of the annual rental permit from \$110.00 to \$120.00 was discussed. ZA points out that the County Inspection Fee and the Town Rental Permit Fee are presently both \$110.00 per annum and that has caused some confusion for property owners.

Wiharm motions to recommend the Town Board increase the annual Rental Permit Fee form *from* 110.00 to 120.00, Soucek seconds, 5 Ayes motion carries.
