- <u>ESB Plan Approval</u>. Sarah Schram, Rick Reichkitzer, Jay Wiltz, Alan Hardie, Red Eldred, Bill Defoe, Jim Patterson, and Mike Anderson will meet with Robert Krzyzanowski from Wendel to do a final review of the modified ESB plan on Monday 3/9. • The Wisconsin DOT Multimodal grant awards were announced on Wednesday. The Town applied for funds to fix the entrance/exit to the dock that is being undermined by high water. Unfortunately, the Town was not awarded a grant. The towns of Port Wing in Bayfield County and Morse in Ashland County received town grants. One of the goals was to spread the money across the state evenly, with counties, cities and towns as separate categories. Of the 1600 applications, 152 were funded, with 84 of those being towns.
