#### Notes:

There are several permits pending and it is anticipated there will be an increase in Zoning activity this Fall.

- Town Permit Revenue reflects 3,460.50 permit fee for the Emergency Services Building. In consideration the Town revenues are 2,864.00 to date. Revenues for the Town Permits are down 60%. With the inclusion of the ESB permit revenues are down 12%.
- Total permit revenues through Zoning are down 13%
- Permits issued by the Town are down 32%
- Total Revenues are down 19%
- Permits issue by the County are up 44%
  - County revenues reflect filling and grading related to riprap installation
  - Zoning is tracking sanitary permits issued by the County
- There is a new wetlands ordinance ordained by the county on July 15<sup>th</sup>, 2020. The Town ZA is seeking:
  - Consultation via the Towns' Attorney and the Ashland County Zoning Administrator
  - A link to this ordinance has been added to our web and an article related to this ordinance will be placed in the next Gazzette.
