  - a. Robert Hartzell invited to the Town Plan Commission to present possible plans for recently purchase land parcels 014-00206-2001 70A and 014-00206-1600 19.49 and 014-00206-0100 5.59A in the R-1 Residential District, single family low density (previously owned by Pan-O-Gold Baking Company).

Mr. Hartzell presented plans of initially developing 25 -26 1-acre parcels, which conforms with Zoning requirements. He is in the process of having the property surveyed. He did not elaborate on other plans though indicated he would like to come back to the Town Plan Commission to discuss other possibilities not addressed tonight.

b. Review Certified Survey Map #278 lot 2 parcel # 014-00020-0320 (Myers, Owner) 3705 Big Bay Road and lot 1 parcel # 014-00020-0320 (Fahien). Recommendation to approve or deny to the Town Board.

Reviewed and seen as an out lot and as such is ineligible for building, the Town Board has recognized the County's ordinance that the County Trunk Highway creates two separate parcels leaving some of those on the Lake side non-conforming to Zoning requirements.

Starck motions to recommend approval of this CSM to the Town Board, Wilharm seconds, 5 Ayes motion carries.

c. Review and discuss Ashland County Wetland Conservation Ordinance in effect as of 7/15/20.

The ZA is still waiting for a legal opinion from the Town's Attorney as to the applicability of this ordinance. Whether it applies to all properties on the island or just the County jurisdiction of 1,000 feet shoreland.
