Township of La Pointe and members of Town Board: Florida MRF Truck Research Trip

As many or most of you know by now the La Pointe Public Works Department has been on the hunt over the last couple of months for a newer hooklift truck to haul solid waste and recyclables from the MRF to the mainland. To fill the shoes of the beloved old Beast, we've been searching for a truck in the used market that can do what's needed to keep our MRF hauling moving forward into the future, as well as pick up other tasks for Public Works in areas that hooklift trucks can excel.

At this time, we believe that we've found two trucks in the state of Florida which both have strong possibilities of becoming a great addition to the Town Of La Pointe. Though we've had many phone conversations with the dealers and lots of research into just the right combination, it would be prudent at this time to go in person and look at both of them before deciding on a final purchase.

The first truck is a 2006 International in Jacksonville Florida. It comes with a Galbreath hoist very similar to the hoist on the Beast, a tarper, Allison automatic transmission and was a government owned/maintained truck. This truck has only 50,000 miles and 3,700 hours on it, which is very low for a specialized truck. The asking price is \$63,500.

The second truck is a 2007 Mack in Avon Park Florida, near Orlando. This truck also comes with a Galbreath hook, it has an 8 Low Low transmission and only 100,000 miles. This was a fleet owned and serviced truck and would come with many new parts including: clutch, turbo, radiator, rebuilt front differential and new paint. The asking price is \$49,500.

With your approval we would like to send Evan and Joe to Florida to look at these trucks and possibly purchase one. They would drive down in Evan's pickup as visit both dealers before a decision was made. With the nature of the used truck market being tight in this category, they'd like to take a check down with them for the purchase of a truck. Taking a blank check would allow them to get a good look in person and perhaps haggle on the price in person to get the town the best deal possible, without the chance of losing the sale waiting for future approval. The more expensive of the two has an asking price of \$63,500 and it is possible that the final price may be lower.

Thank you for your patience and consideration during the hunt for the right truck as we weed through hundreds of options that did not meet our criteria. We look forward to
