Introduction from Debbie Knopf, President of St. John's Church Council

Good evening. I'd like to introduce our committee that will be presenting to you this evening. Pastor Rachel of St. John's Church; Mary Whittaker, Board Chair of Woods Hall; Debbie Knopf, President of Church Council; Ron Harrold, Vice President of Church Council; Gwen Smith-Patterson, artist and member of St. John's; Carol Neubauer member St. John's and Town Treasurer.

We are here in response to an invitation, or request, the Church Council received in November 2020 from the Town Board. This request was an invitation to explore assuming responsibility for what has been historically known as "The Exchange" here on the island.

Our committee met weekly for the past several months and engaged discussions with Church Council and the Woods Hall Board as we explored and developed what we believe can be a working plan. We have also conferred with Lisa Potswald and Town staff to answer specific questions or concerns.

Consideration and Integration of Information from the Final MRF Report

One of the first steps we took was to review the "Final MRF Report" regarding "The Exchange," presented to the Town Board in June of 2020. The survey results indicated that our community values re-use in general and very strongly supports having a physical space on the island to accommodate it.

- 90% of survey respondents think it is important to have an Exchange
- 78% are willing to bring usable items to an Exchange
- 90% think a new Exchange should be expanded

In addition to numerous written statements of support, affirming strong community interest, there were a number of concerns raised and suggestions made for improvement. These fell, roughly, into three categories:

- 1. Access and ease of use relating to hours of operation, being in cramped space, and lack of organization.
- 2. Inventory management variety of comments regarding setting limits on what gets dropped off and how to keep things from simply piling up; and getting rid of things at the end of the year.

3. Management – several comments acknowledged that running an operation like the Exchange requires serious management and noted that better management plans were needed, similar to Goodwill or the ABC Thrift Shop.

The MRF Final Report made a number of Recommendations including honoring the community desire for a functional and successful "re-use" center. These included:

Providing responsible management, with adequate guidelines and procedures •

- Operating it with paid staff
- Communicating its place in the larger campaign to 'reduce, reuse, recycle.'
- To tap community support to help with the project
- To have policies in place to make sure "stock" keeps moving & doesn't pile up.

This full report was submitted in June 2020. In the months following, the Town reassessed its capacity to provide appropriate oversight and management of an Exchange project, given its current staff and work load. A decision was made to seek a 501c3 partner, such as St. John's, to develop a collaborative partnership. Our committee has used the recommendations of the MRF Report in creating its plan.

The "Fit" with St. John's

Another important question to answer was, "is this a good fit for St. John's?"

The stated vision of St. John's UCC is "to be a church and spiritual center for the whole community" and we see this project strongly aligned with that vision. Just as St. John's has taken on other missions to serve our community, such as Woods Hall, the Food Shelf, supporting the Community Garden, and Wellness and Balance classes for individuals, a program such as an Exchange would serve the broader community of Madeline Island, helping to meet essential needs of its residents.

St. John's also strives to be an organization that cares for the earth. This project is a way for us to directly act on that value because it is centered in recyling, upcyling, re-use and re-purposing (i.e., decreasing items going in to the landfill). We also look forward to opportunities, through this project, to support education for our community on how upcycling can be an important part of creating and sustaining our environmentally responsible community.

While St. John's does not have additional funding to put into this endeavor, other than some initial start up funds, we do feel a strong commitment to find ways to make this a sustainable service for our community.

Business Plan

As this is a new endeavor under a new model we have given it a new name: The Island Closet a ministry of St. John's UCC on Madeline Island

Purpose

1. To establish an environment whereby the Madeline Island Community can repurpose a variety of personal and household items.

- 2. To support a project that cares for our natural environment by facilitating recycling, reuse and repurposing.
- 3. To extend the church's mission of heling meet the essential needs of the Madeline Island community. The ability to offer clothing, household goods, etc. at no or reduced cost will be possible through the donations of those who support this project.

Season of Operation & Open Hours

The Town is offering use of the building to the church from April 15 to October 15, at which time it will need to be emptied for the winter season. We are proposing, for 2021, to be open to the public from May 15 through October 10, after taking the month of April for set-up. We will operate only on the days the MRF is open (currently Monday, Wednesday and Saturday). The hours of operation would be 9am-2pm for the public, however the manager would be on site from 8:30am – 2:30pm for cleaning, organizing and overseeing drop-off of goods.

Start-Up Costs

A number of tables, shelving units and clothing racks will need to be purchased initially, in addition to printed signage, additional lighting, two small heating units, and an addendum to our insurance policy to cover any liability issues.

Total estimated start-up costs are \$2500 plus first month of Manager's wages (\$1672) for a total of \$4172. We have secured a loan for that amount from St. John's Unrestricted Memorial Funds.

Ongoing Costs of Operation

- 1. Rent of building: \$6.00. (\$1.00 per month, April 15 to October 15)
- 2. End of Season Disposal Fees: \$300 estimate
- 3. Porta Potty pump out, once a season \$80.00 (Porta Potty donated by Island Septic)
- 4. Employee: 1 manager @ \$18.00 per hour at 18 hours a week

Wage of \$18/hr x \$18 hrs/wk = \$324 + 20% payroll (\$64.80) = \$388.80/wk \$388.80 x 4.3 weeks = \$1671.84/month, six months = \$10,031.04

Summary of operating costs:

\$10,417.04 for the season divided by the five months we will be open =

\$2083.41/month \$ 484.51/week \$ 161.50/day

It is our hope that monetary donations from our community will cover these expenses for a clean, well-operated program.

Manager would be responsible for being onsite during MRF operating hours. And needs to work respectfully with MRF staff and Church Council.

"The Island Closet" can't operate without the help of volunteers. The job of the volunteers involves assisting the manager and will answer to the manager with the day to day operations of the "The Island Closet." These duties may include:

- Assisting the manager with setting up the "Island Closet" at the beginning of the season.

- Assisting the manager with tearing down the "Island Closet" at the end of the season.
- Put material donations on shelves and tables
- Tidy up shelves and tables
- Sweep the floor
- Accept material donations when manager not available
- Deny material donations that are not acceptable when manager not available
- Cover shifts if manager is not available, including opening and closing for the day
- Clean porta jon
- Take excess clothing and other material donations to second hand stores
- Accept cash donations
