5. Update on Survey & Forum Findings (Northland)

Northland gave an overview of the survey and forum data, including analysis, themes, key takeaways and next steps.

- Dominant values include natural environment, unique sense of place, community, self-sufficiency, and overall quality of life.
- Categories discussed: housing, business activities and services, community and cultural life, sustainability and resiliency, land use, transportation, civic engagement, and governance
- Collective responsibilities for Plan development include: plan for resilience and adaptation to climate change; taking a holistic approach to transportation, land use, housing, and economic development topics; smart public investment strategies; diversify transportation options; and use the community planning process as an educational opportunity about the purpose of planning, including explanations and rationales for proposed actions.
- Proposed committee responsibilities include: developing vision framework, obtaining more data from and about renters, more education about housing needs

- and opportunities, engaging younger full-time residents, developing a list of underutilized assets on the island, truth-testing property tax complaints, sharing additional data with Northland by mid-November.
- Where Northland will go from here: research assistants will produce a written summary of this presentation, students will conduct research on comparable communities and best practices based on goals in vision framework (specifically rural affordable housing, transportation, economic development, climate action planning and sustainable agriculture).

General discussion on presentation, including overall differences between year-round vs. seasonal residents, and shoreline erosion.
