5. Presentation from Northland

Nicole gave presentations prepared by students on: Charter Schools, Healthy Communities, Local Food Systems, and Sustainable Tourism.

- Charter Schools: advantages and challenges were presented, though research tends not to focus on rural communities. Overall student feeling was to stay with Bayfield School District. Presentation included suggestions on next steps.
- Healthy Communities: Research looked at built environment, active transportation, expanding rural health-care access, and improving social infrastructure and programming.
- Local Food Systems: High survey support. Research focused on Food Hub concept and ideas to increase availability and production. Nicole noted a cooperative food feasibility study grant is available from the WI Office of Rural Prosperity.

• Sustainable Tourism: Ideas presented include green tourism (Travel Green WI), low-impact tourism, sustainable winter and shoulder season tourism, agri-tourism, and cultural and indigenous tourism.

Michael K had e-mailed a proposed timeline revision. Brian is looking for direction from the committee on what topics/projects to expand on and research, as well as what areas on the plan they should work on. Committee will meet to digest presentation and contemplate next steps. Nicole will e-mail presentation to the committee the beginning next week.
