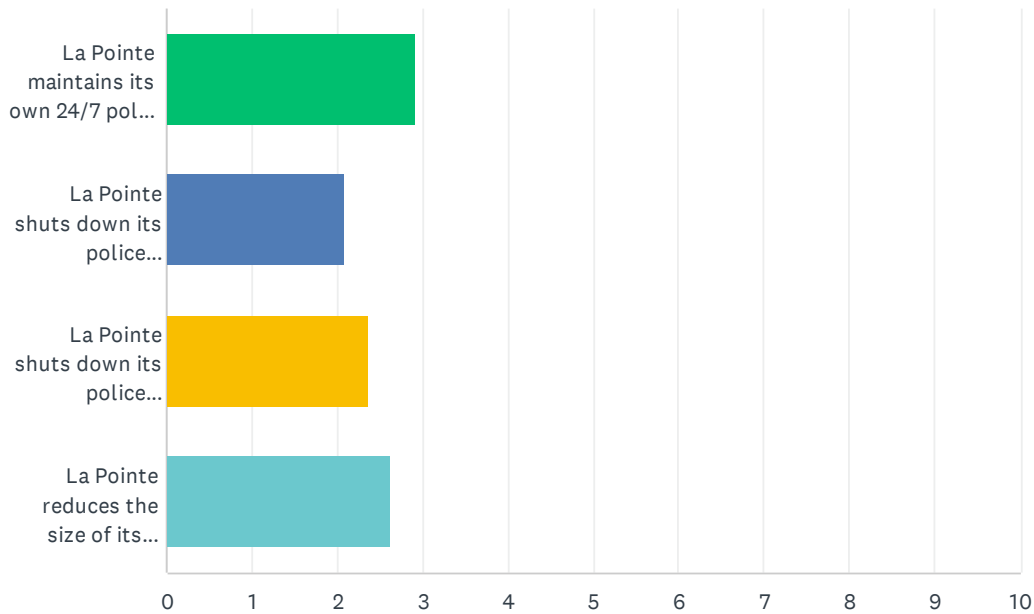

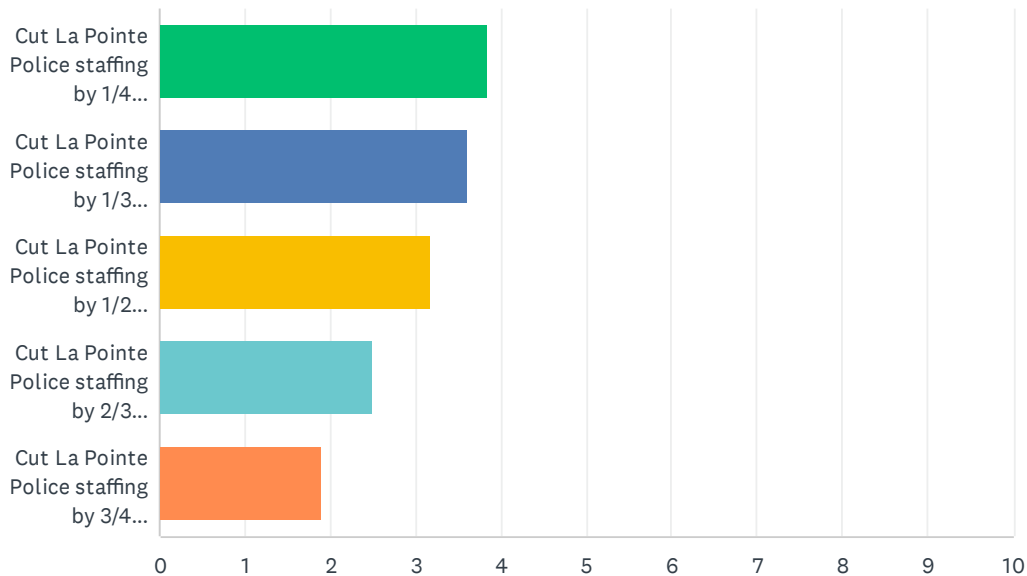

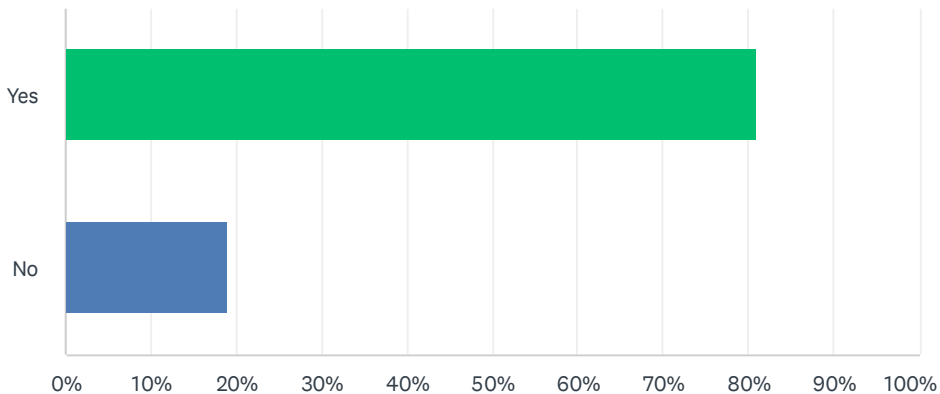

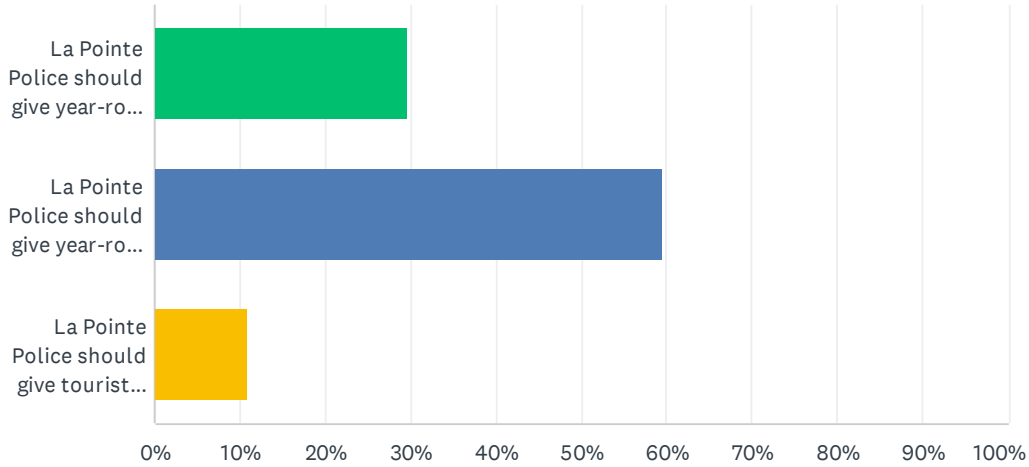

Q13 In your opinion, in what ways should La Pointe Police treat year-round residents, seasonal residents, and tourists differently?

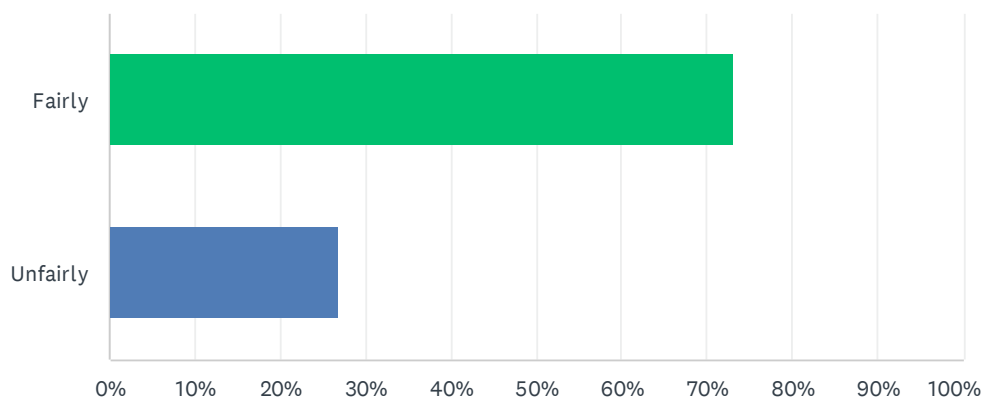

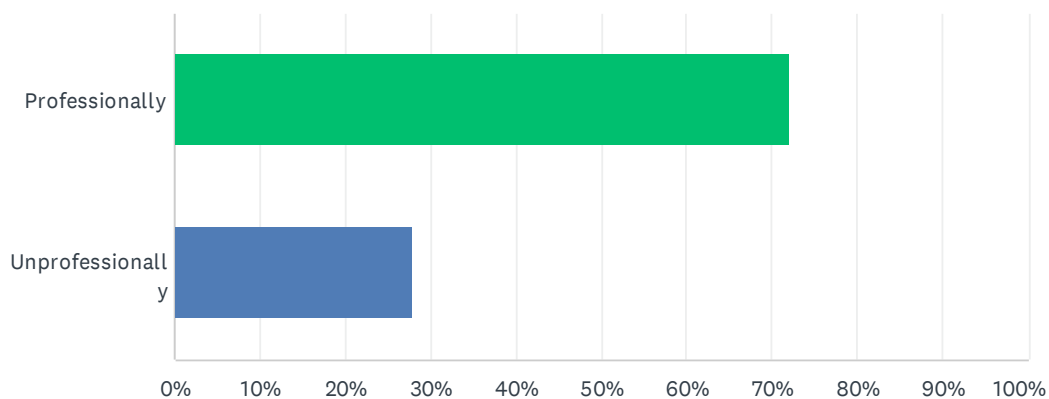

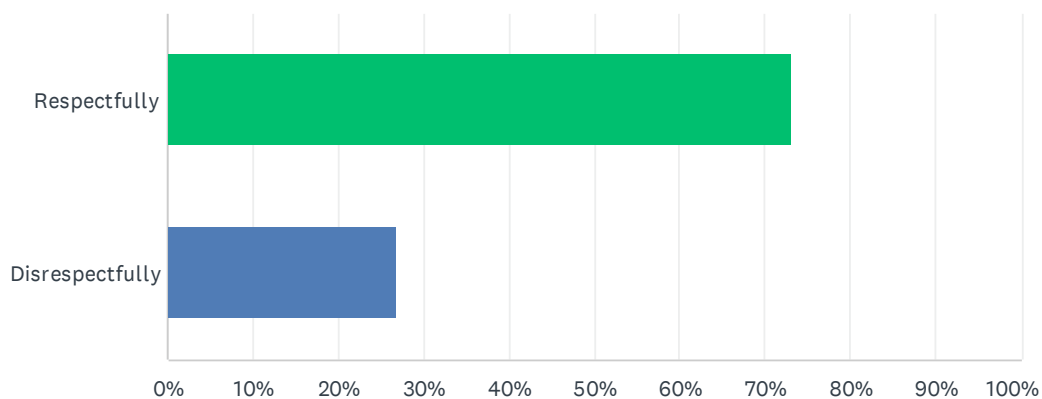

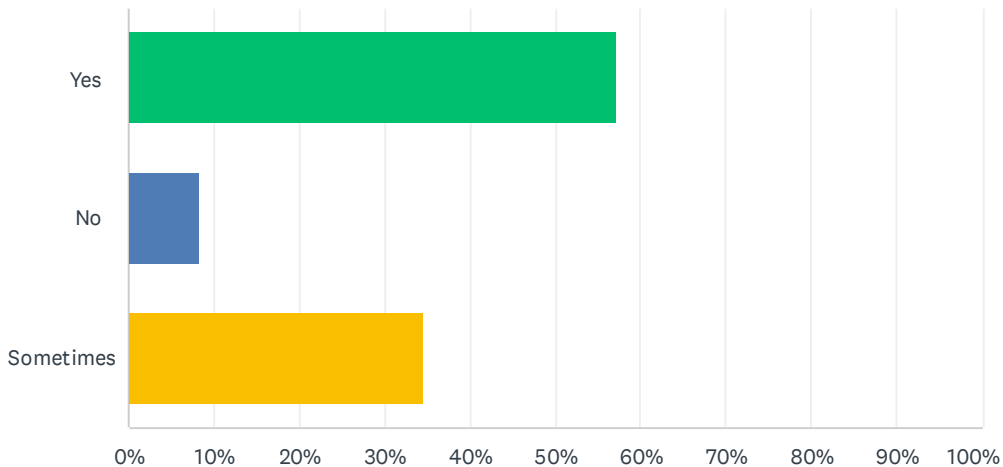

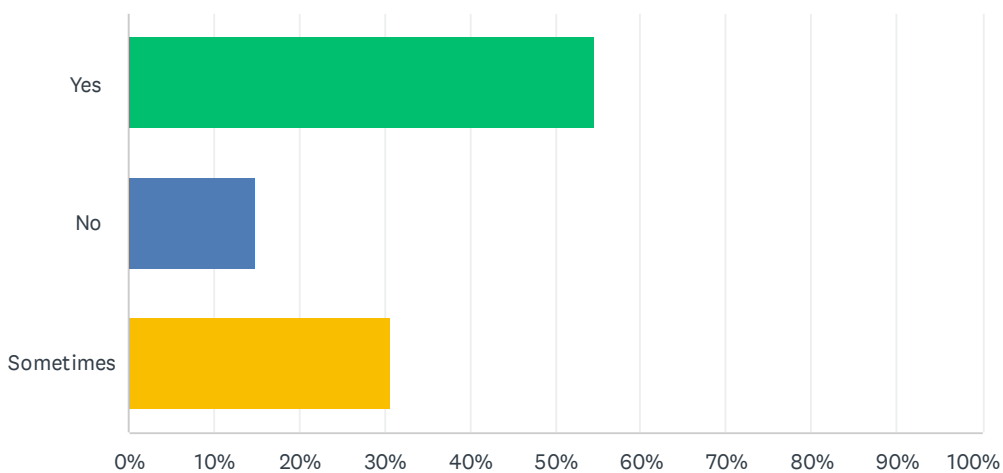

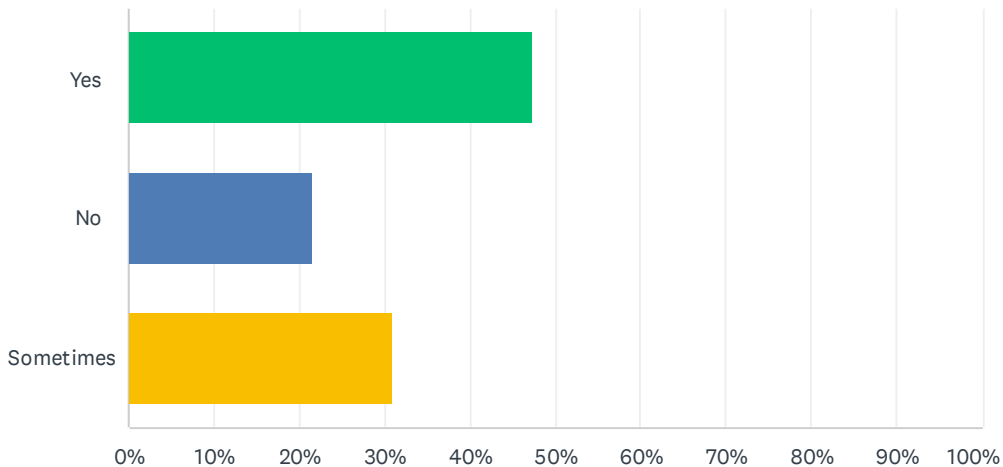

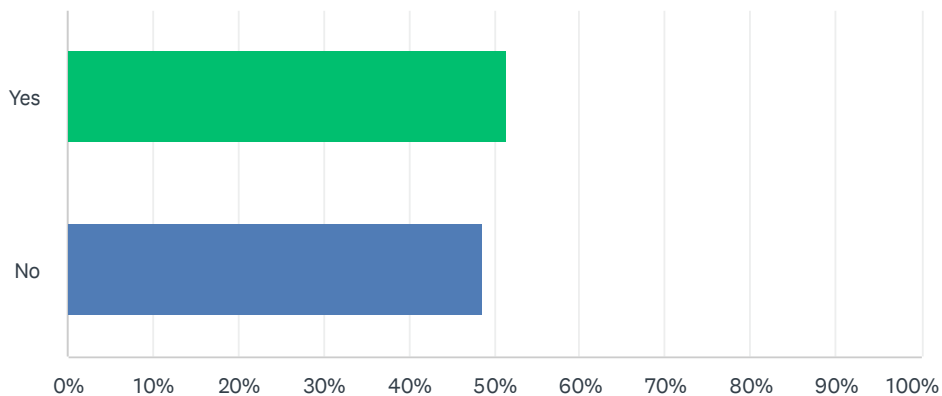

Q20 La Pointe Police patrol primarily in a vehicle. If staffing and time allow, should they patrol more on foot?

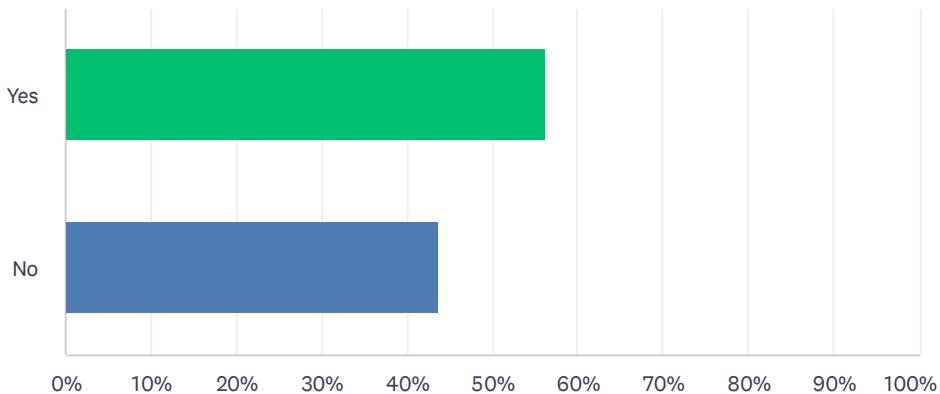

Q21 La Pointe Police patrol primarily in a vehicle. If staffing and time allow, should they patrol more on bicycle?

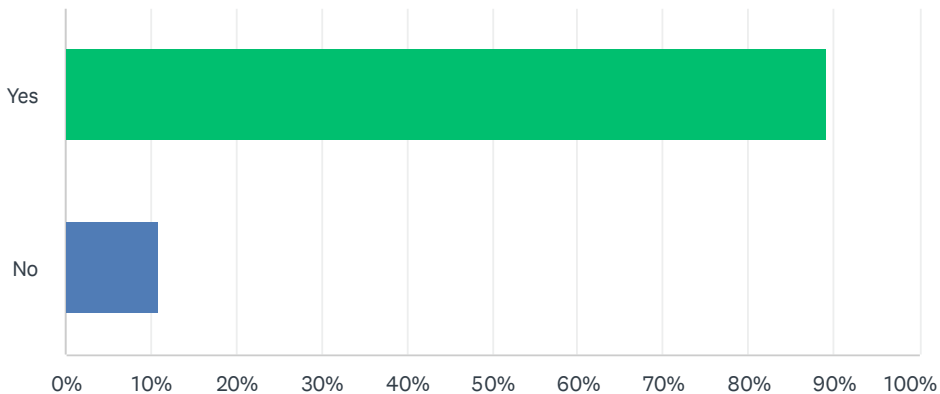

Q22 In your opinion, is it important for residents to know their police officers and for police officers to know residents?

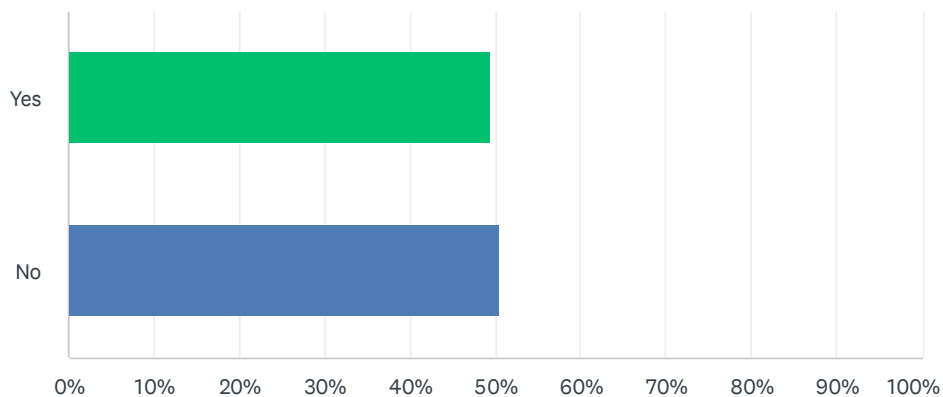

Q23 Do you personally know a La Pointe police officer?

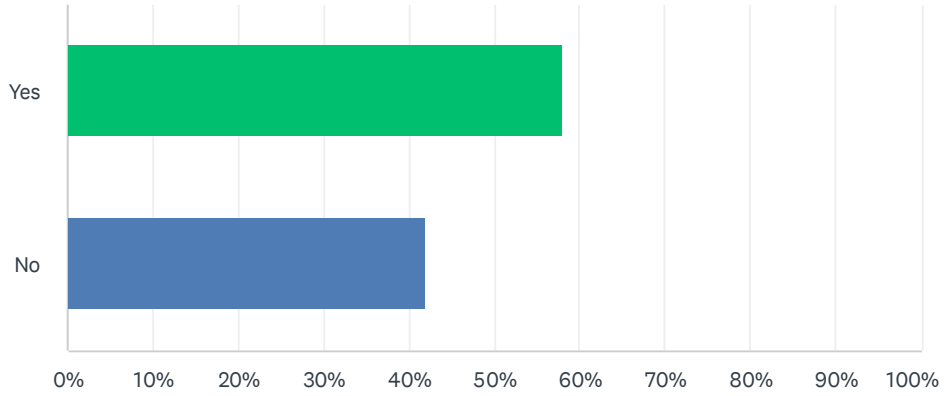

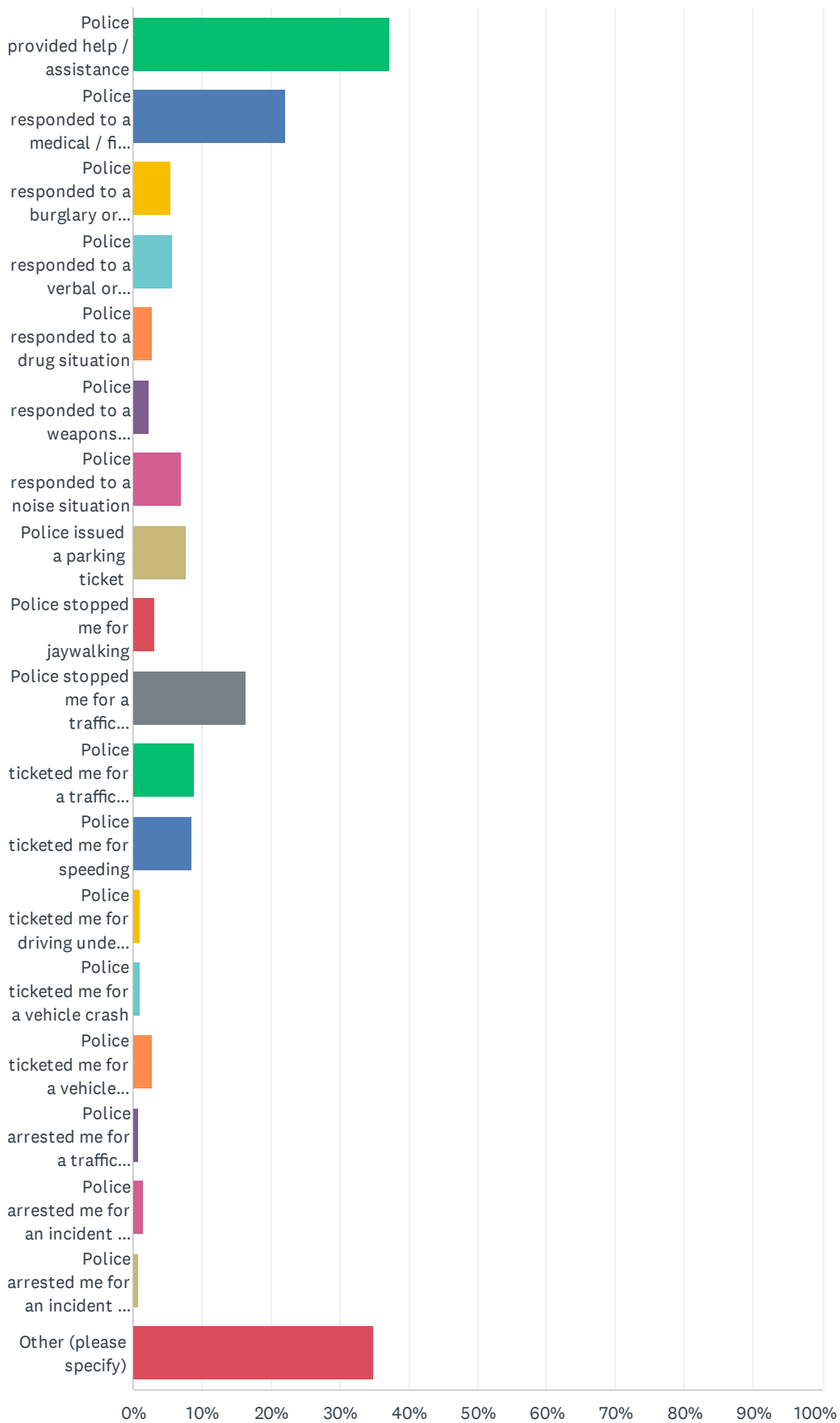

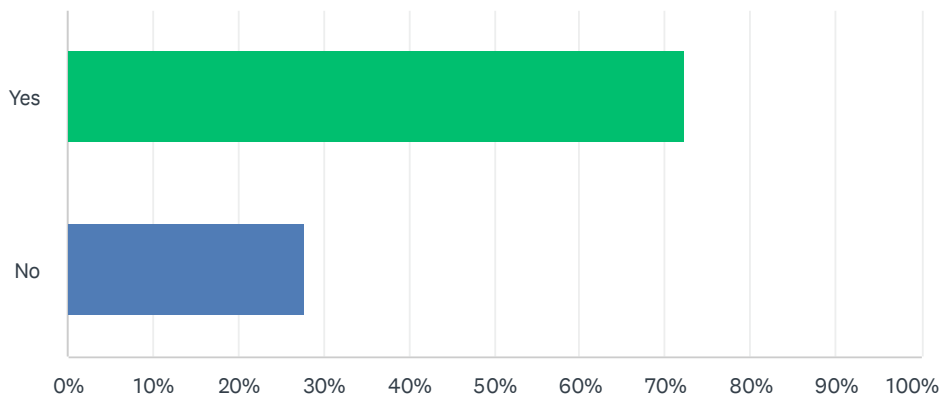

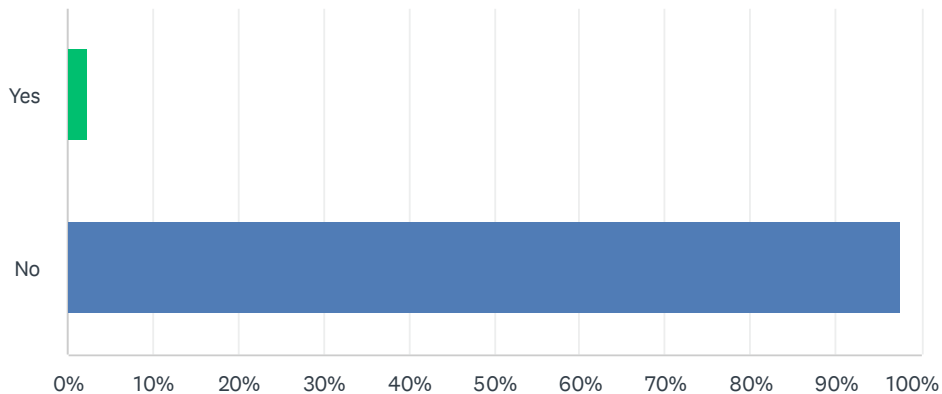
