December came and went with not much activity, once again with the bars closed, we are able to get away with less. We are still seeing visitors to the island, visiting the state park and the town park. If there is an ice road, I would assume we may have a record year for traffic.

December 18, 2020 through Jan 1, 2021, we participated in the national campaign Driver Sober Get Pulled over. I can report that there were no arrests for impaired driving. Our agency will be put into a drawing for a \$4,000 equipment grant.

On June 16, 2020 President Trump issued an Executive Order on Safe Policing for Safe Communities. Part of the Executive Order instructs that the US Attorney General will allocate Department of Justice discretionary grant funding only to those State and local law enforcement agencies that have sought or are in the process of seeking appropriate credentials from a reputable independent credentialing body certified by the Attorney General. The Attorney General's standards for certification shall require independent credentialing bodies to, at a minimum, confirm that:

- The State or local law enforcement agency's use-of-force policies adhere to all applicable Federal, State, and local laws; and

- The State or local law enforcement agency's use-of-force policies prohibit the use of chokeholds except in those situations where deadly force is allowed by law.

I am happy to report that we have received our accreditation from Wisconsin Law Enforcement Accreditation Group (WLEAG) as of December 29, 2020 for our Use of Force Policy that was written by myself and updated this past fall. WLEAG is approved by the Attorney General to do accreditation for law enforcement agencies.

Dear Chief William Defoe,

On behalf of the Wisconsin Law Enforcement Accreditation Group, this letter confirms we are certifying that the La Pointe Police Department meets certain eligibility requirements, set forth by the U.S. Department of Justice, for discretionary federal grants. The La Pointe Police Department is qualified to receive federal grants for three years from the date of this letter.

Pursuant to Section 2 of the Presidential Executive Order on Safe Policing for Safe Communities, dated June 16, 2020, Executive Order No. 13929 (the "Executive Order on Safe Policing"), the U.S. Department of Justice's discretionary grant funding is only available to state, local, and university or college law enforcement agencies that have obtained (or are in the process of seeking) credentials certifying that they meet certain standards on use of force. The Executive Order on Safe Policing empowers the U.S. Attorney General to designate independent credentialing bodies — including the Wisconsin Law Enforcement Accreditation Group — to certify that a law enforcement agency meets the conditions of eligibility for federal grants.

Following our review, we have determined that the La Pointe Police Department meets the mandatory conditions for certification. Accordingly, the Wisconsin Law Enforcement Accreditation Group will include your agency going forward within our database of certified law enforcement agencies. On or before January 31st of each year, we will provide the name of each certified law enforcement agency to the Director of the COPS Office.

January was a typical January for the Police Department; we have been taking this time to prepare for the big move into the ESB once it is completed.

We have been working on parking lots, as a reminder trailers can not be left in Town parking lots that are not attached to a vehicle. Lot W on Whitefish next to the school has a 14-day limit until April 1 when it turns to a 4-day limit. It is posted at the entrances of the parking lot, yet we tend to have several people who park and leave their vehicles there for long periods of time. If you want to leave your vehicle for a long period of time, a long-term parking permit is available at the town hall for Lot W. We may even be able to arrange to post for a reserved personal spot.

It looks like we will have a windsled season. Parking down in the windsled parking lot is only 4 days, and we are already seeing people park there. We will be pretty strict with the time limit in that parking lot as filling it up is not fair to the daily commuters.

Officers have been taking some online training, but the trainings only give 1-4 hours each and we all are required to have 24 hours of training a year by state law. The online training is few and far between, more than previous years, but most of it is not relevant to our officer's needs. Officers may have to attend in person training this spring, however, they are limiting participants in these trainings and taking precautions. I did not go to the Chiefs training this year, they however did limit capacity and took a lot of precautions.

Calls were slightly up in Feb, would have been more if the ice road would have lasted longer than 36 hours. Many of our calls were answering questions about the ice road and times of transportation across via Windsled inc.

As of Mid-February, all regular officers working for the Town of La Pointe have been vaccinated. We all were administered the shot at the Ashland County Nurses office in Ashland.

Speaking of the vaccine, I was asked at the beginning of February to assist the Wisconsin Department of Health in transporting vaccine to our clinic on the island. To this day, I had made three trips across the ice whether it be in the windsled or drove to the crack and met a courier to accept the vaccine. Nate and Arnie Nelson were a great asset to help get the vaccine here.

In person trainings are starting to get ramped up again, we will be looking at in person training for officers. To this day, officers will need to have a mandatory 24 hours total Inservice training by June 31, 2021 or they will lose their state certification. There are limited online trainings we have been able to do, but an hour here and there is not conducive and many of the trainings available do not apply to our department (gang training and school resource officers for examples). We are actively looking at in person training, I was able to get most of the officers into Ashland's patrol officer Inservice, as someone will have to work while they are at training, I may have to leave the area to complete my own.

There were still a few tourists that drove over the crack, a couple even got stuck over there. Calls were slightly up, but I credit that to more people coming over when the ferry started back up.

The last few weeks of the month were dedicated of moving into the new Emergency Services Building. We went through a lot of things and are still working out the kinks in the new digs. It is amazing on how fast spaces fill up and it will take some time to make things just right.

Most of the officers are going to WITC in Ashland for their 24 hours of mandatory training in April, as I have to cover the island while they are there, I will be headed to WITC in Rice Lake in May. After that, the department is good with mandatory training for the fiscal training year that ends June 30th. We will still be doing some inhouse training as well.

As the bars are looking at opening back up, we will have to have the conversation in the near future on staffing for the police department. Last fall I was told to not replace my 3rd full time officer, at the time with covid keeping bars closed it was not a big deal. Now that things are ramping back up, bars are opening again, we will not be able to cover the island they way we had been in the past with our current staffing. I have been trying to recruit part time officers, but it has not been successful. I will be putting out a more thorough memo soon.

With our current staffing, and normal summer business, we will not be able to patrol hours we would be doing normally. I am working on a solution, hopefully I will be able to present it to the board in the next few weeks.

Officers attended training at WITC in Ashland in April, Mike Syphard and I will be attending WITC in Rice Lake in May to complete our mandatory 24-hour training for the fiscal year. We will still have to have some mandatory inhouse training such as firearms, arrest tactics and taser refresh. The Taser instructor we have used in the past is no longer in law enforcement, Sgt Rossberger took it upon himself to go become a taser instructor so we can also hold annual taser refresh and be compliant.

We have been spending a lot of time at the new hall, organizing, reorganizing, and moving things from the office in the town hall to the ESB and generally, going through things. The new hall has been a learning curve and finding bugs here and there. We are looking forward to the full competition.

We are officially shorthanded, with the number of calls and service needs going up, we will not be able to staff the way we had pre covid 19. The search continues, I will be presenting in the future to replace the 3rd full time officer now. I had been trying to go without it, it is not going to work.

All fiscal year training with a small exception of a qualifying mandated firearms qualification, have been met for the year, as of July 1 our new fiscal training year will be starting. We will not be waiting until the last minute this time to complete our mandatory training. Officers will be going to training at the end of summer into the fall to get ahead of our needs.

Our new part time officer has started and is currently in field training for the next month. So far, he has been a quick learner and should be ready to go solo in September.
