- c. Approval Process Town of La Pointe's ZA can approve driveways and land disturbance applications. La Pointe's Town Plan Commission must approve anything else. Reviews are conducted on the 1st Wednesday of each Month. (Special meetings can be requested for earlier reviews, for a \$500 fee.)
- **d.** Current Fees In process of being updated for 2026.

- b. Submit both La Pointe & Ashland County Applications, when needed If your project is within 1,000' of the Shoreline of Lake Superior, both are needed.

- d. Don't Forget to Sign Completed Applications
- e. Sanitary Permits are Required Before ANY Land Use or UDC Permits are Issued.
- f. Complete the Plot Plan in Full
- **g. Post Your Permits** Please remember to pick up your permits at Town Hall and post them on your property.
